Terms and Conditions

This agreement allows you to divide your fall tuition charges into equal payments over the course of the fall 2009 semester. This agreement must be received by June 30, 2009, for Option #1 or August 1 for Option #2. If the agreement is not received and all of the requirements are not met by June 30 or August 1, 2009, you may incur a \$50 per month nonrefundable late fee. If the account becomes more than five days past due, Point Park will withhold academic records and deny the privilege to register for future semesters. A \$25 late fee will be assessed on all late payments. If the balance is not satisfied by the last scheduled payment date, a \$50 per month late fee will be applied until the balance is paid in full.

If you withdraw from the University, the refund policy described in the Point Park University course book will be applied.

Requirements

This agreement must be completed in full and submitted with the nonrefundable \$40 application fee for Option #1 or \$75 application fee for Option #2. If you are signing the agreement on the date that a payment is due, you are responsible for paying the application fee and any payments that are currently due or are past due.

By signing this agreement, I agree to all terms outlined. I further agree and understand that if I do not pay the entire amount due, I may incur additional costs for collecting the amount due including attorneys' fees, court costs and collection agency fees.
